OPERATING AGREEMENT

OF

World Wide Widgets, LLC

AUGUST 26, 2021

This Operating Agreement (this “**Agreement**”) is effective as of August 26, 2021, by Homer Simpson (“**Homer**”) and Marge Simpson (“**Marge**”) and World Wide Widgets, LLC, an Arizona limited liability company (“**Company**”).

A. The Company is a newly formed Arizona limited liability company.

B. The Trust will be referred to as the “**Member.**” Homer and Marge will be referred to collectively as “**Managers**” and individually as a “**Manager.**”

C. The parties to this Agreement desire to conduct the business and affairs of the Company under the terms and conditions set forth below.

Article 1

Formation, Name, Purposes

Section 1.1 Formation

The Company is subject to Arizona Revised Statutes Sections 29-3101 through 29-4201, as amended from time to time, which statutes are known as the “Arizona Limited Liability Company Act” (the “**Act**”). The Company was created on the filing of its Articles of Organization with the Arizona Corporation Commission. The Member shall from time to time sign or cause to be signed all such certificates, fictitious name or business statements and other documents, and make or cause to be made all such filings, recordings and publishings, and do such other acts as the Managers may deem necessary or appropriate to comply with the requirements of law for the formation and operation of the Company in all jurisdictions in which the Company desires to conduct business. The Managers will cause the Company to be qualified or authorized to do business in any jurisdiction in which qualification or authorization is necessary to conduct the Company’s business.

Section 1.2 Name

The name of the Company shall be “**World Wide Widgets, LLC.**”

Section 1.3 Definition of the Term Act

The term “**Act**” means and refers to Arizona Revised Statutes Sections 29-3101 through 29-4201, as amended from time to time, which statutes are known as the “**Arizona Limited Liability Company Act.**”
